Budget Officers Report

BO Laskowski discussed. Budget sessions previously were mid March but can do earlier if decided to. Mayor said the loan for the building; we were anticipating using the gaming fund to pay for it. The \$6400 we are putting back monthly is for the IEPA loan. Motion by Trustee Vessles to approve the budget officers report. Trustee Jenkins 2nd. Approved 4-0. Budget study session will be set at next meeting.

Engineers Report

Project 6899-Water Improvement/tower/IEPA loan-Ron Legner said they are processing the shop drawing from both contractors. Foundation work complete. The 2nd loan disbursement request has been submitted to IEPA Water tower erection is expected to begin in March; completion at end of November. Change order request needed. This if for additional electrical panel and conduits to be added for power supply to telemetry building – operate the old radios. Keep power running to the little building, 200 amp electrical panel and power feed to keep operational until URWC comes along, increase of \$7634.60, will be added to the IEPA loan. Motion by Trustee Jenkins for Mayor Deverell to sign this change order. Trustee Ditty 2nd. Approved 4-0.

Loop Water Main and existing tower rehab-efforts to finalize an agreement for last easement needed continues. Legal agreement has been forwarded to the property owners for review. A loan application should be submitted to IEPA by 3/31 to increase the chance of receiving grant money for construction of new water main and/or water tower rehab before July 2022. Can apply but not committed until you sign. Ron Legner thinks it will be ok to postpone.

Drainage improvements-Chastain created a new drainage contour map using Lidar data and satellite photos for discussions/planning for improving storm drainage in problem areas of village.

Coop Water main/existing water tower rehab- All 4 trustees, Vessels, Acree, Ditty and Jenkins wants to wait on this; currently no money to do this.

Gouge Road-village has no use. Mayor has asked the Trustees to look at this road to see if they want to give it up.

Interconnect Pump Station-backflow preventor is required. We installed pump station. Will repair 3 phase power supply per Ameren \$9144.88 to install (power pole and transformer) \$2557.90 up front, balance on agreement, over 7 year period. More details are needed. Legner will request more info. Tabled

3rd Easement for water main loop-Ron Legner forwarded to property owners-nothing back yet. Offered \$4820. Motion by Trustee Acree for Mayor Deverell to sign the Brown Anderson for easement thru the property. Trustee Vessels 2nd. Approved 4-0.

Public Works-

Report received from our public works employees. A report was also received from LJ Water-no major concerns.

Electrical at new pole barn – ok to pay when the bill is received Electric door openers for public works building- 2 quotes received. \$3335 Door Specialities; \$3000 Illini Overhead Doors. Does this include key pad on exterior wall, is there a warranty, what is brand and horsepower? Mayor Deverell till find out these details

Vaccinations for Employees for COVID 19-IML said municipalities have authority to require or mandate vaccination of employees. Mayor Deverell does not think employees will be willing. Poll of Trustees on whether they would want to require the vaccination; Trustee Acree no; Trustee Vessels, yes; Trustee Mooney no; Trustee Jenkins no . Tabled. EJ Water could help in case of emergency.

2021 Water Rate Increase-did not raise last year until September. Ordinance says raise annually in May. Trustee Acree questioned why raising rates every single year? Mayor said because costs go up every year. This will be discussed in budget session.
