URW tie in-will utilize Harristown's water tower to maintain pressure for Niantic. One booster pump station will be able to supply water for both communities. No check valve. Working on this to get more details. Niantic will benefit without helping with any of the costs involved. Will the new water tower have a mixer? Engineer said yes it will and will retrofit one on the old tower.

Trustee Jenkins stated we need to have an ordinance stating requirements for cattle before they can apply for a special use permit. Ordinance committee will look at a special use permit ordinance.
